



**Tribal Council Resolution 2023- 04**  
**Farm Greenhouse Grant**

**WHEREAS**, Skagway Village (dba Skagway Traditional Council) is the federally recognized tribal government for all enrolled tribal citizens in Skagway, Alaska; and

**WHEREAS**, Skagway Traditional Council is responsible for the health, safety, welfare and Cultural preservation of its tribal citizens and use of the Skagway Traditional Council's traditional territory; and

**WHEREAS**, Skagway Traditional Council's traditional territory reflects all lands and waters historically and presently occupied and utilized by the Skagway Native people since immemorial, and land within the modern-day community of Skagway and Dyea as identified in STC Constitutions, Article II Section 1; and

**WHEREAS**, Article IX Section 3(g) of the Constitution of STC specifically directs the STC Tribal Council "to protect and preserve Tribal property, wildlife, and natural resources of importance to the Tribe;" and

**WHEREAS**, STC recognized the importance of food sovereignty in the Skagway area and purchased a farm at 2.5 Klondike Hwy known as Lazy Daisy Farm; and

**WHEREAS**, the greenhouse and nursery at the farm are in not operating at its full potential and the farm staff sees a critical need for improvement; and

**WHEREAS**, STC has received a full grant funding from Central Council of Tlingit and Haida Indian Tribes of Alaska (CCTHITA) in the amount of \$450,000 to place a commercial greenhouse on the farm; and

**WHEREAS**, funding will be provided through a pass-through funding from the CCTHITA's Tribal Resilience funds received from Bureau of Indians Affair; and

**WHEREAS**, the funding will allow STC to be able to construct a modern and high functioning greenhouse, allow the well to be relocated, and purchase accessories and starting supplies for the greenhouse; and

**WHEREAS**, STC will additionally be able to use the funds to supplement the labor cost significantly helping in offsetting the cost of labor for the farm; and

**NOW THEREFORE BE IT RESOLVED** that the council members of Skagway Village here by accept the greenhouse grant award from CCTHITA; and

**NOW THEREFORE FURTHER BE IT RESOLVED** that the Council members of Skagway Village here by directs the Tribal Administrator or delegate to sign grant award documents and direct the construction of the greenhouse.


